# CONSTITUTION OF WORLD PARTY BANGLADESH

#### **PREAMBLE**

We, the people of Bangladesh gained independence sacrificing the lives of three million people in 1971. We uphold the constitution of the Peoples Republic of Bangladesh. We dedicate ourselves for the peace and stability of our country. We also dedicate ourselves for the betterment of international community.

During this time of globalization we feel it is necessary to work in the concept of World Federation by which the countries of this world can solve their problems and the people can live peacefully. However, with a view to upholding the development and dignity of Bangladesh as well as for the international development, we do hereby establish this World Party Bangladesh

## **Article 1 Name of Organization**

The name of this party shall be "World Party Bangladesh".

#### **Article 2 Office**

- 1. Main office of the World Party Bangladesh shall be located at C/O Advocate Md Mahmudul Hasan, Eastern Mansion (14 th Floor, Suite: 14/06, Road: 67/9 Pioneer Road, Kakrail, Dhaka-1000, Bangladesh. However, the central committee can change the address as per necessity.
- 2. Besides the office in previous paragraph, District and Thana office may be set up as per the permission of central committee.

## **Article 3 Policy**

Basic policy of the World Party Bangladesh, is to work for the betterment of the people of Bangladesh and to contribute for the establishment of World Federation.

## **Article 4 Undertakings**

World Party Bangladesh shall carry out following undertakings to achieve the object in the previous article.

- 1. To uphold the constitution of Peoples Republic of Bangladesh.
- 2. To work for the betterment of the peoples of Bangladesh
- 3. To work for the international peace and prosperity.
- 4. To work for the establishment of World Federation.

#### **Article 5 Members**

- 1. World Party Bangladesh shall recognize a person who is 18 years old and who has approved the object of this Party and has paid the annual party membership subscription 1,000 taka as a regular member.
- 2. A member who did not pay the membership fee for 1 year or more and a member who has got registered without paying the membership fee shall be recognized as a supporting member and shall not have the right of the regular member. While the regular member shall have the right to speak and to vote in the World Party Bangladesh Convention and the World Party Bangladesh Extraordinary Convention and may become an Executive Member of Party, the supporting member may attend at the Convention but shall have no right to speak and to vote and may not become an Executive Member.

#### **Article 6 World Party Bangladesh Convention**

- 1. The World Party Bangladesh Convention shall be the supreme legislative organ of the World Party Bangladesh, and shall discuss and decide on the following issues.
  - (i) Adoption and amendment of this Constitution
  - (ii) Approval of settlement of accounts and budget bill
  - (iii) Report on the result of undertakings and approval of plan of undertakings

- (iv) Election of the President and Central Committee Members..
- (v) Admission of new member and dismissal of member who is inappropriate for party
- (vi) Other issues recognized as necessary by the Convention
- 2. The Convention shall be held once a year as decided by the Central Committee of the World Party Bangladesh.
- 3. The Convention shall be approved regardless of the number of attending members as far as the notice of the Convention had been issued by the President through the ordinary or electric mail or on the Internet at least 1 month before the date of opening and the venue is not difficult to access as compared with other venues.
- 4. All matters in the Convention, except for matters stipulated in this Constitution, shall be decided by more than half of members present, and in case of a tie, the President shall decide the matter.

# **Article 7 World Party Bangladesh Extraordinary Convention**

- 1. The World Party Bangladesh Extraordinary Convention shall be convoked when one of the following conditions is fulfilled and shall become the supreme legislative organ of the World Party Bangladesh.
  - (i) When the President judged that the Extraordinary Convention is necessary
  - (ii) When more than 30% of the members of the World Party Bangladesh required it
  - (ii) When more than 30% of branches required it.

When one of the above conditions is fulfilled, the President shall hold the Convention within 1 month.

- 2. The Convention shall be approved regardless of the number of attending members as far as the notice of holding the Convention had been issued by the President through the ordinary or electric mail or on the Internet at least 10 days before the date of opening and the venue is not difficult to access as compared with other venues.
- 3. All matters in the Convention, except for matters stipulated in this Constitution, shall be decided by more than half of members present, and in case of a tie, the Chief Election

Commissioner shall decide the matter.

#### **Article 8 International Secretariat**

While the World Party and the World Party Bangladesh are legally independent organizations. However, by virtue the World Party Bangladesh accepts the "Memorandum of Understanding" (MOU) with the World Party. This MOU is completely informal proceeding and not binding upon the law.

#### **Article 9 President**

The President shall be elected from among candidates in the World Party Bangladesh Convention. The term of office of the President shall be 2 years, and the President cannot be elected for more than one term consecutively. It means the current President cannot be the candidate in upcoming election as President. However, giving one term (Two years) gap, he/she can be the candidate again. But he can run for the post other than President.

#### **Article 10 Central Committee**

The Central Committee are composed of the President, the Vice-President, the Secretary-General, Assistant Secretary General, the Public Relations Officer, the Treasurer, Office Secretary. All of the central committee members will be elected by the direct election. But the first center committee will be selected by the President of World Party. The Central Committee can remove any of its members by the decision of 2/3 majority in any convention. However, no member can be elected for more than one term consecutively. It means the current member of central committee cannot be the candidate in upcoming election as same previous post. However, giving one term (Two years) gap, he/she can be the candidate again for the same previous post. But he can run for the post other than his previous post.

#### **Article 11 Functions of the Central Committee**

- 1. The President shall represent the Party, convoke the World Party Bangladesh Convention, the World Party Bangladesh Extraordinary Convention, and the Board of Central Committee, and shall become the Chairperson of the session.
- 2. The Vice-President shall assist the President, and when the President cannot perform her or his functions due to some reasons, shall deputize for the President. When the President

has resigned or passed away, the Vice-President shall become the President. The term of office shall be remaining term of the former President.

- 3. The Secretary-General, by command of the President, shall issue instructions to the Secretaries and shall carry out her or his functions. Assistant Secretary General will co-operate the Secretary General and perform its duty in absence of Secretary General.
  - 4. The Public Relations Officer shall announce the official statement of the Party.
  - 5. The Treasurer shall deal with the income and expenditure of the Party.
  - 6. Office Secretary shall maintain all official activities as per the instruction of President or Secretary General.

#### **Article 12 Board of Central Committee**

- 1. The Board of Central Committee shall be composed of the President, the Vice-President, the Secretary-General, Assistant Secretary General, the Public Relations Officer, the Treasurer, and Office Secretary. It shall be convoked by the President and shall decide the issues such as the venue and the date of the World Party Bangladesh Convention and the World Party Bangladesh Extraordinary Convention, the budget bill, and other necessary matters. All matters shall be approved by the World Party Bangladesh Convention or the World Party Bangladesh Extraordinary Convention. However, all matters shall be approved by the World Party Bangladesh Convention or the World Party Bangladesh Extraordinary Convention.
- 2. The resolution shall be valid if more than half of the Central Committee members are present. Or, the resolution shall be valid regardless of the number of attending Central Committee as far as the notice of the Board of Central Committee had been issued by the President through the ordinary letter, or the electric mail, or the Internet at least 1 months before the date of opening and the venue is not difficult to access as compared with other venues.
- 3. All matters in the Board shall be decided by more than half of Central Committee present, and in case of a tie, the presiding officer shall decide the matter.

## **Article 13 Branch and Member**

1. Branch of World Party Bangladesh can be founded in each District and Thana. New branch shall be, as far as there is no particular objection, authorized without condition by the World Party Bangladesh Convention. New branch shall be refused or existing branch shall be dismissed when the Convention resolved that the branch is inappropriate for the World Party

Bangladesh. The headquarters of World Party Bangladesh shall have its members and the branches also shall have their members. When there is no branch in a District and Thana, members of the District and Thana shall be registered as members of headquarters.

- 2. Qualification of the member of headquarters shall be specified by this constitution, and the qualification of the member of each branch shall be specified by the Central Committee. New member of headquarter shall be, as far as there is no particular objection, authorized without condition by the Convention. An applicant for joining the party shall be refused or current members shall be dismissed when the Convention resolved that they are inappropriate for the Party. Each branch can accept new members and dismiss inappropriate members following the decision of the central committee. But, the Convention also can dismiss the members of each branch by its resolution.
- 3. Members of the headquarter shall pay the party membership fee to the headquarter and members of each branch shall pay the party membership fee to the branch. Each branch shall pay 40% of revenue of the branch to the headquarter as the party fee. The amount of fee that the members of the headquarter and of the branch pay shall be decided by the Convention.

## **Article 14 Impeachment**

- 1. In the World Party Bangladesh Convention and the World Party Bangladesh Extraordinary Convention, the President shall be removed if two-thirds or more of the members present resolved on the removal of the President. When the President has been removed, new president shall be elected within 40 days. In this case, process of election is commanded by the Election Commission.
- 2. Central Committee other than the President also may be removed by the impeachment by 2/3 Majority. When Central Committee other than the President has been removed, the President may appoint new member of different Central Committee until the next election.

#### **Article 15 Vote of Member**

In the World Party Bangladesh Convention and the World Party Bangladesh Extraordinary Convention, each member shall have 1 vote. The vote may not be entrusted to other member.

# **Article 16 Budget and Assets**

Sources of budget and assets shall be composed of the party membership fee and the donation. Fiscal year is from 1st January to 31st December.

## **Article 17 Delegation of Decision**

Matters not stipulated in this Constitution shall be decided by the Board of Central Committee.

## **Article 18. Election Commission:**

The Election Commission will be consisted of One Chief Election Commissioner and two Election Commissioners. Any member of the Election Commission cannot be candidate of that election where he is appointed as Chief Election Commissioner and Election Commissioner. The central committee will deal the appointment of Election Commission who will organize election with free, fair and impartially.

#### **Article 19 Enforcement**

This Constitution shall be enforced from 31 October 2018.
